2021 CESA SAFETY GROUP APPROVED TRAININGS

All member organizations in the CESA Safety Group must have at least one person attend or participate in at least two approved training programs each year to receive the 4% group premium discount at the next renewal, and to be eligible to receive CESA Safety Group program dividends. Choose from the following training options:

- **Training offered by or sponsored by CESA and VFIS that has been pre-approved by Pinnacol, which is relative to CESA members and emergency service organizations; AND/OR**
- **Safety Group Approved in-person trainings conducted by Pinnacol Assurance (when available), and the Pinnacol J.J. Keller interactive webinar online trainings.**

The CESA Safety Group will schedule Safety Group Approved CESA/VFIS online trainings to be conducted via Zoom. We will send out emails with information when the trainings are confirmed for 2021.
